We celebrate diversity and instill integrity, compassion, and confidence.

The Williams School is an accredited kindergarten through 12th grade day school that seeks to teach the whole child with special emphasis on children with reading and other learning difficulties. Our goal is to provide an environment where each student feels safe, secure, loved, and respected. We seek to provide each child the opportunity to grow to their fullest potential, graduate from school, and become contributing members of society. We focus individual attention on the needs of each child with small class room sizes with no more than 6 to 8 students per class room. For school year 2020-2021, the school had 15 students enrolled, with 12 participating in class, 2 participating fully online (pandemic related), and 1 hybrid in class and online. No students graduated this year. Education of enrolled children is our main program at the school. Note: See section O for explanation of safety precautions taken during Covid-19.

The Williams School provides extra-curricular experiences to students with field trips through out the school year. The school also provides some outdoor activities, for example archery training. Students also participate in planning and executing fund raising activities, and other festivities during the school year. One example is the traditional Spring Prom dance. This variety of activities fit nicely into our mission goal stated previously. Please note that most of these activities were severely curtailed during the school year due to the ongoing Covid-19 pandemic and due to our switch to online learning during this time. We hope to resume normal activities during the next school year.

Teachers are provided with training opportunities to further their professional development and improve their skills. Covid tests were administered regularly to students and school faculty and staff. Temperatures were taken every day before entrance into the school. Faculty and students were required to wear masks, spacial distancing was maintained in each class, and standard CDC guidelines were followed, including students remaining at home for quarentine if infected, and required to test negative before returning to the classroom setting. Deep sterile cleaning was conducted regularly at the school by a 3rd party cleaning contractor. The school maintained a safe environment through out the school year. All school faculty and staff were fully vaccinated.

Form 990, Part VIII, Line 1e - A PPP (paycheck protection plan) US government Loan of \$35,300.00 is listed as a government grant here. This was part of the continuing Covid-19 relief packages provided by the US Federal Government in 2021 (also granted in 2020). The school was fully compliant with all loan requirements and the loan was fully forgiven (it was also forgiven in 2020). The loan helped to offset enrollment disruptions resulting from economic hardships resulting from the Covid-19 pandemic.
